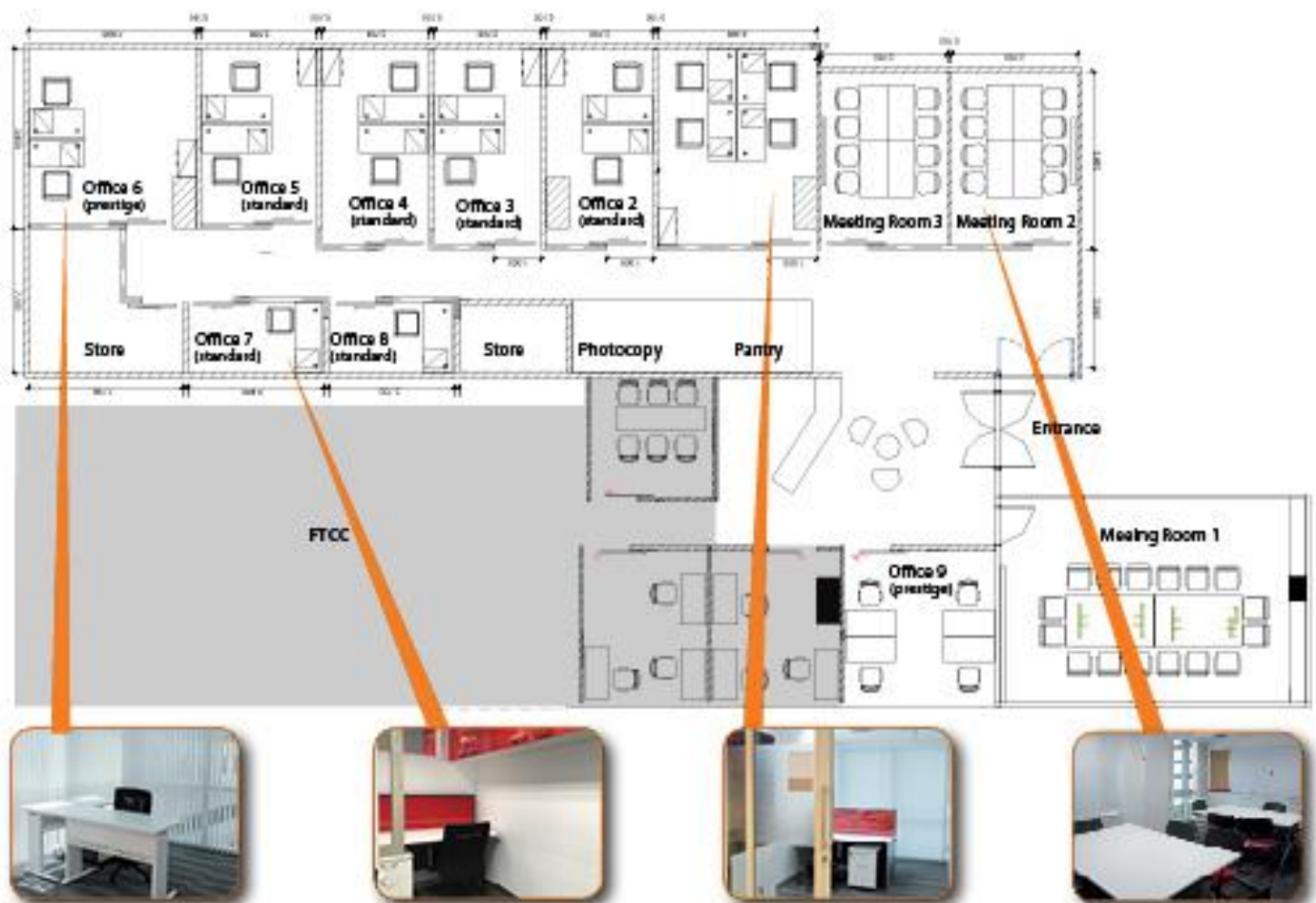

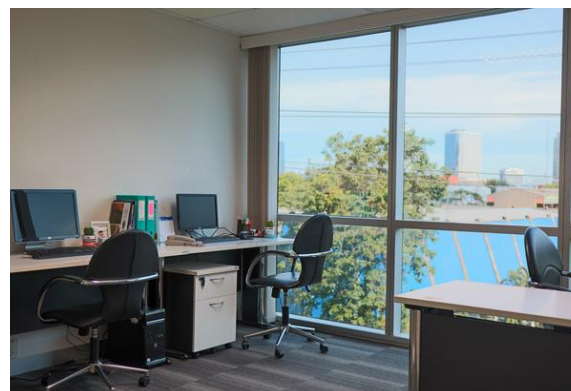

# ADMINISTRATIVE PROCEDURES

The Franco-Thai Chamber of Commerce (FTCC) facilitates all administrative procedures for you to assure that you will settle down smoothly.

**Visa non-immigrant B:** delivered by Thai Consulate abroad, it is the visa needed for those wishing to work in Thailand as only the person with this type of visa can be issued work permit. Its validity is 3 months with a possibility to renew every three months during one year in Thailand.



**Minimum salary :** A foreigner working in Thailand is considered as a highly qualified employee. The minimum wage is 50 000 THB per month to obtain work permit.

**Work Permit:** Once arrived in Thailand, within 30 days, the foreigner must go to the Ministry of Labour to ask for a work permit, with health certificate, three identity photos and passport with more than 6-month validity. The work permit is valid for one year renewable.
